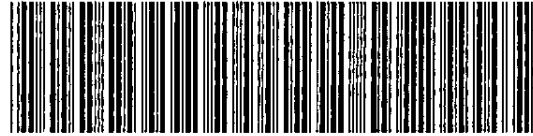




1. The current name of the Corporation is La Quinta Cafeteria & BBQ, Inc.
