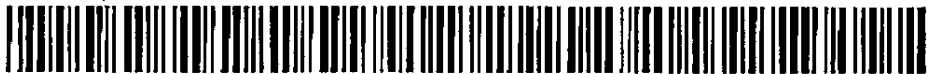

ARTICLE I

Corporate Name and Principal Office




