The undersigned incorporator, for the purpose of forming a corporation under the FLORIDA Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be: Kind Words and Cool Water, Inc.

ARTICLE II - PRINCIPAL OFFICE
