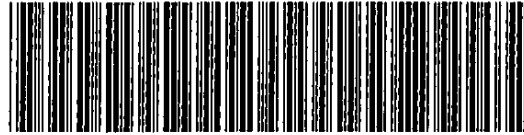



CERTIFICATE OF INCORPORATION

FIRST. The name of this corporation is _____




