ARTICLES OF INCORPORATION OF EL MEGACHUZO HOLDINGS, INC.

A FLORIDA CORPORATION

The undersigned subscriber to these Articles of Incorporation hereby forms the corporation under the laws of the State of Florida, as follows:

FIRST: The name of said corporation shall be El Megachuzo Holdings, Inc., a Florida Corporation. The mailing address and the street address of the principal office of the corporation shall be: 1200 North East, Miami Gardens Drive, Unit 404, N.M.B., Florida 33179,

SECOND: El Megachuzo Holdings, Inc., a Florida Corporation, shall have a perpetual duration from the date of filing of these Articles of Incorporation.

THIRD: The sole purpose for which El Megachuzo Holdings, Inc., a Florida Corporation, is formed is:

- Owning and operating a food and related ancillary services as permitted by Florida law.
- Any other lawful purposes as permitted y Florida law. **b**)

FOURTH: The maximum number of shares of stock that this corporation is authorized to have outstanding is one hundred (100), all of which shall be identical units, and each of which shall represent the ownership of that percentage of the total units outstanding at any time as is the equivalent of the ratio in which one (1) is the numerator and the total units outstanding is the denominator.
