The undersigned subscriber to these Articles of Incorporation hereby forms the corporation under the laws of the State of Florida, as follows:

FIRST: The name of said corporation shall be El Megachuzo Holdings, Inc., a Florida Corporation. The mailing address and the street address of the principal office of the corporation shall be: 1200 North East, Miami Gardens Drive, Unit 404, N.M.B., Florida 33179.

SECOND: El Megachuzo Holdings, Inc., a Florida Corporation, shall have a perpetual duration from the date of filing of these Articles of Incorporation.

THIRD: The sole purpose for which El Megachuzo Holdings, Inc., a Florida Corporation, is formed is:
