ARTICLES OF INCORPORATION

<u>ARTICLE I - Name</u>

The name of this corporation is CARS AND TRUCKS OFF LEASE INC.

ARTICLE II- Duration

This corporation shall have perpetual existence. ARTICLE III-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - Capital Stock

This corporation is authorized to issue 7500 shares of Common Stock with \$1.00 par value.

Each of said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders.
