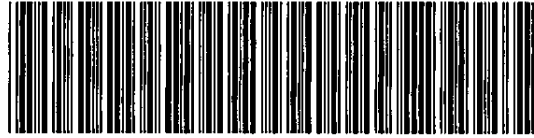

**ARTICLES OF INCORPORATION
OF
ONSITE CONSTRUCTION MANAGEMENT, INC**

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I- NAME OF CORPORATION

The name of this corporation shall be Onsite Construction Management, Inc.

ARTICLE II- DURATION

This Corporation shall exist perpetually.

ARTICLE III- INITIAL PRINCIPAL OFFICE

The initial principal office of the Corporation shall be located at 1515 Egan Drive,
Orlando, Florida 32822

ARTICLE IV- PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business purposes.

ARTICLE V- CAPITAL STOCK

- A. The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share, which may be fractional shares.





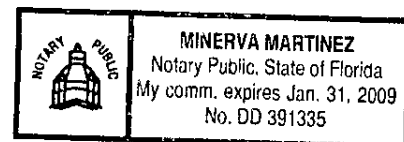
