ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND PRINCIPAL OFFICE OF CORPORATION

Natures Select of Tampa Bay, Inc. shall be the name of this corporation, and the mailing address and its principal office shall be: 2151 Harbor View Drive, Dunedin, FL 34698.

ARTICLE II - NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III - CAPITAL STOCK
