



ARTICLES OF INCORPORATION OF CALVERT VICTORIA, INC.



Article I - Name

The name of this corporation is CALVERT VICTORIA, INC.

Article II - Duration

This corporation shall have perpetual existence, commencing on MAY 10, 2007.
