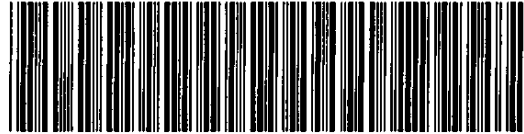

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

### ARTICLE I NAME

The name of the corporation is and shall be Ebony Woodworks, Inc.

### ARTICLE IX BYLAWS AND AMENDMENTS

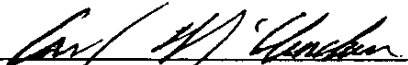
The power to adopt, alter, amend or repeal bylaws and amendments shall be reserved to the shareholders holding a simple majority of the voting power of the corporation.
