# ARTICLES OF INCORPORATION OF MAIDS 4 HIRE, INC.

The undersigned do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### ARTICLE 1 - NAME AND ADDRESS
