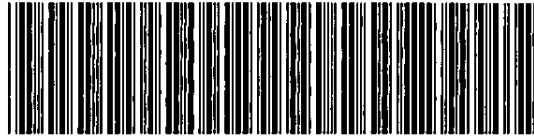



ARTICLE I

The name of this corporation is MAR DESIGN COLLABORATIVE INC.



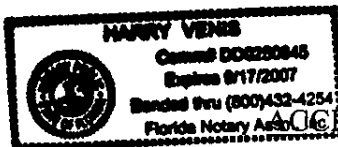


