ARTICLES OF INCORPORATION OF COAST TO COAST COMMERCIAL INS., INC.

THE UNDERSIGNED subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State LORIDA of Florida.

ARTICLE I - NAME

The name of this corporation is COAST TO COAST COMMERCIAL INS., INC.

ARTICLE II - NATURE OF BUSINESS

To the same extent as natural persons might or could do, the Corporation shall have the power:

- 1. To carry on any lawful business whatsoever which the Corporation may deem proper or convenient, or which may be intended directly or indirectly to promote the interests of the Corporation or to enhance the value of its property.
