The undersigned, for the purpose of forming a corporation for profit under the laws of hereby adopts the following Articles of Incorporation:

ARTICLE I Florida, hereby adopts the following Articles of Incorporation:

ARTICLE II Principal Office

The principal office and mailing address of the corporation shall be 14402 Marina San Pablo, Suite 201, Jacksonville, Florida 32224.

ARTICLE III Duration

This corporation shall exist perpetually.  - Preemptive Rights. Shareholders shall have no preemptive rights. (b)
 - Cumulative Voting. Cumulative voting shall not be permitted. (c)
- Restrictions on Transfer of Stock. The shareholders may, by bylaw provision or by shareholders' agreement recorded in the minute book, impose such restrictions on the sale, transfer or encumbrance of the stock of this corporation as they may see fit.

ARTICLE VI Initial Registered Office and Agent

ARTICLE VII Directors

- (a) <u>Number</u>. This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one.
