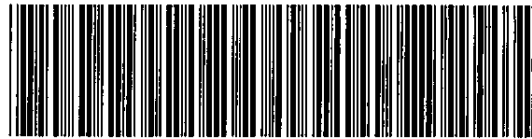

The undersigned incorporator for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

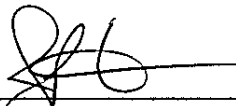
- FIRST:** The name of the corporation is MAXTEK DISTRIBUTING, INC., a Florida Corporation (the "Corporation").

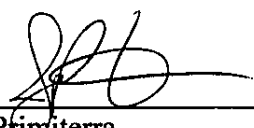
