# ARTICLES OF INCORPORATION OF

#### ARTICLE I - NAME

The name of the corporation is Destiny Uni-Sex Salon, Inc., at 4270 Minton Road, Suite #115, Palm Bay, FL 32904 (Principal Office of Registered Agent).

#### **ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
