ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I - Name

The name of this Corporation is REINHART AUTOMOTIVE SERVICES, INC. The principal place of business of this Corporation shall be 414 Moffat Loop, Oviedo, Florida 32765 or such other place as may be designated by the Board of Directors.
