**AMENDED AND RESTATED
ARTICLES OF INCORPORATION

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following restatement to its Articles of Incorporation:

This corporation filed its Articles of Incorporation on May 24, 2007 and was assigned Florida Document Number P07000061841 (the "Original Articles"), and an amendment was filed on September 14, 2009 (the "First Amendment") to the Original Articles. These Amended and Restated Articles of Incorporation are being filed to record certain amendments to, and to restate, the Original Articles inclusive of the First Amendment.

Article I. Name

The name of the corporation is MAJESTIC JET, INC. (the "Corporation").

Article II. Principal Office

The principal place of business and mailing address of the Corporation shall be 1401 NE 10th ST, Pompano Beach, Florida 33060.

Article III. Purpose

The purpose for which the Corporation is formed is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act, as amended from time to time.

Article IV. Capital Stock

The authorized number of shares of stock of the Corporation is 2,000,000 shares of common stock having \$0.01 par value per share.

Article VII. Indemnification

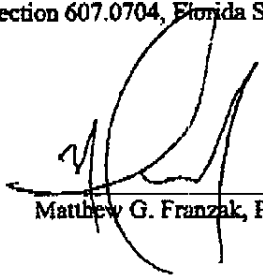
The directors and officers of the Corporation shall be protected from personal liability to the fullest extent permitted by law.
