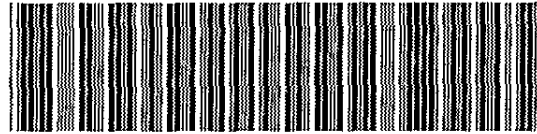



I, the undersigned, certify that I hereby organize for the purpose of becoming a Professional Corporation under the laws of the State of Florida, in compliance with Chapter 607 and Chapter 621, F.S., providing for the formation, rights, privileges, and immunities of professional corporations. I further declare that the following Articles shall serve as the Articles of Incorporation and authority for the conduct of business of the Professional Corporation ("the Corporation").

**ARTICLE I
Name**

The name of the Corporation shall be **MAHONEY DERMATOLOGY SPECIALISTS, P.A.**

**ARTICLE II
Principal Office**

The principal place of business/mailling address and street address of the Corporation is: 7198 122nd Way North, Seminole, Florida 33772.

**ARTICLE III
Purposes And Powers**

The purpose of the Corporation is to practice the profession of medicine in the State of Florida. The sole and exclusive professional services to be rendered by the company are:

a. To engage in the practice of medicine as a professional corporation and to own and operate a medical office for the purposes of providing medical care and treatment

b. To promote medical, surgical and scientific research and knowledge; to furnish related laboratory and clinical services; and to own real and personal property, enter into contracts, and engage in any lawful business necessary for the rendering of the professional medical services.

c. To do everything necessary, proper, or convenient to accomplish any of the purposes set forth in these articles, and to do every other act incidental to the corporate purposes which is not forbidden by Florida laws or by the provisions of these articles of incorporation.

d. The purpose of the Corporation shall be carried out only through officers, employees, members and agents, each of whom is licensed or otherwise legally qualified to render medical services in the State of Florida.

ARTICLE IV
Shares Authorized

The maximum number of shares this Corporation is authorized to issue is 50,000, par value \$1.00 per share, all of which shall be common shares.
