

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of Shamrock Bank of Florida are hereby amended as follows:

<u>FIRST</u>: Section 3 of Article V of the Articles of Incorporation is hereby amended by deleting the text thereof in its entirety and substituting the following in lieu thereof:

Section 3 – Election and Term: At each annual meeting of shareholders of the Bank, the shareholder shall elect directors to hold office until the next succeeding annual meeting. Each director shall hold office for the term for which such director is elected and until such director's successor shall have been elected and qualified or until such director's earlier resignation, removal from office, or death.

SECOND: The foregoing amendment was adopted by the holder of all the outstanding shares of common stock, being the sole voting group entitled to vote on the amendment, on April 29, 2008 and the number of votes cast for the amendment was sufficient for approval by the holder of common stock.
