Articles of Incorporation

Pursuant to the Statutes of the State of Florida, the undersigned intends to form and create securioration and therefore does hereby state and certify the following:

Article I

The name of the corporation is Wickroff Enterprises, Inc.

Article II

The purpose for which the corporation is formed is to engage in any lawful acts or activities for which corporations may be organized under the laws of the State of Florida.

Article III

If a majority in number representing three-quarters (3/4) in value of the creditors or class of creditors, or of the shareholders or class of shareholders to be affected by the proposed compromise or arrangement or a reorganization, agree to a compromise or a reorganization of this corporation as a consequence of the compromise or arrangement, the compromise or arrangement and the reorganization, if sanctioned by the court to which the application has been made, shall be binding on all the creditors or class of creditors, or on all the shareholders or class of shareholders and also on this corporation.


