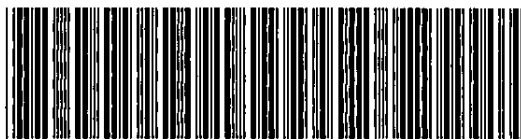

ARTICLES OF INCORPORATION

ARTICLE I-NAME

The name of this corporation is **ARD, SHIRLEY AND RUDOLPH, P.A.**

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of engaging in the practice of law as a professional association. The practice of law, including without limitation the provision of governmental affairs consulting, shall be the sole and exclusive professional service to be rendered by this corporation.

ARTICLE IV-CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

ARTICLE V-PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI-INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 207 West Park Avenue, Suite B, Tallahassee, Florida 32301, and the name of the initial registered agent of this corporation at that address is Scott Shirley.

ARTICLE VII-SHAREHOLDERS

The corporation shall have no directors. All corporate powers shall be exercised by or under the authority of, and the business affairs of this corporation shall be managed under the direction of, the shareholders of this corporation.

ARTICLE VIII-INCORPORATORS


