## **ARTICLES OF INCORPORATION**

**FIRST:** The name of the corporation (which is hereinafter called the "Corporation") is "Signature Paper Company."

**SECOND:** I, Kellie C. Allen, whose post office address is 52 Riley Road Suite 374, Celebration, FL 34747, being at least eighteen (18) years of age, hereby form a corporation under and by virtue of the general laws of the State of Florida.

**THIRD:** The purposes for which the Corporation is formed are:

1. To provide custom paper creations; and to engage in any other lawful purpose and/or business; and
2. To do anything permitted by Chapter 607, as amended from time to time.

**FOURTH:** The total number of shares of capital stock which the Corporation has the authority to issue is five thousand (5,000) shares of common stock, without par value.
