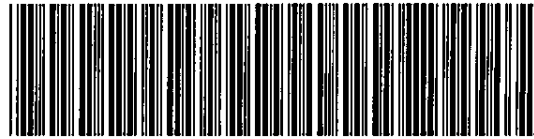

The Corporation may issue 100 (One HUNDRED), of Voting Common Stock of Par value \$ 5.00-- each Share with preemptive Rights preserved

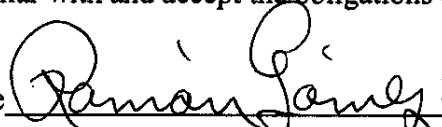

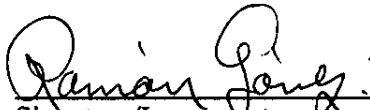

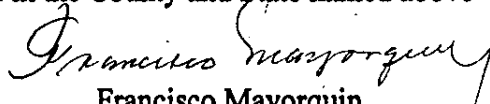
