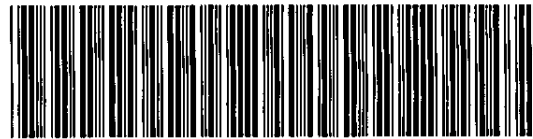

## ARTICLES OF INCORPORATION

The undersigned incorporator for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST: The name of the Corporation is **Tessa Haspil-Corgan, MD, PA** (The Corporation).

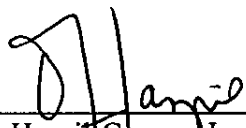

- SIXTH: The Corporation is also organized for the purpose of transacting such other lawful business for which corporations may be formed under Chapter 607 of the Florida Statutes, and in compliance with Chapter 621 of the Florida Statutes as a Professional Association.

SEVENTH: The Corporation shall have one director initially and the number of directors may be increased or diminished from time to time as provided in the bylaws but shall never be less than one.
