CORPORATE EXISTENCE**



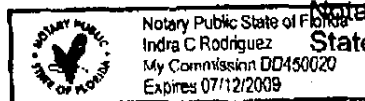
