

ARTICLES OF INCORPORATION
of

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME: The name of this corporation shall by **GINNIS & GROYSMAN, P.A.**

ARTICLE II

ADDRESS: The mailing address and street address of the initial principal office of the corporation shall be 600 South Andrews Avenue, Suite 406, Fort Lauderdale, Florida 33301.

ARTICLE III

NATURE OF BUSINESS: The corporation is organized for the purpose of providing legal services and for transacting any and all business for which corporations may be formed under Chapter 621 of the Florida Statutes, as amended from time to time.

ARTICLE IV

CAPITAL STOCK: This corporation shall be authorized to issue 1,000 shares of \$1.00 par value common stock.

ARTICLE V

TERM OF EXISTENCE: This corporation shall have perpetual existence.

ARTICLE VI
