**ARTICLES OF INCORPORATION
OF
FROMYER COMMERCIAL MAINTENANCE COMPANY**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: Fromyer Commercial Maintenance Company.

ARTICLE II

The existence of the Corporation shall begin on: June 1, 2007.

ARTICLE III

The street address of the principal office of the Corporation is: 6802 Spencer Circle, Tampa, FL 33610.

ARTICLE IV

The specific purpose for which the Corporation is organized is:

- (1) the maintenance of commercial or residential properties and;
- (2) such other lawful purposes as permitted by the Florida Business Corporation Act.

ARTICLE V

The maximum number of shares this Corporation is authorized to issue is 1,000,000, par value \$0.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.


