**ARTICLES OF INCORPORATION  
OF**

**ARTICLE I - NAME OF CORPORATION**

The name of the corporation is BUSTED KNUCKLES CUSTOMS, INC. (the "Corporation").

**ARTICLE II - CORPORATE ADDRESS**

**ARTICLE III - CAPITAL STOCK**

This corporation shall have authority to issue One Thousand (1,000) shares of Common Capital Stock having a par value of \$0.01 per share.

The street address of the Corporation's initial registered office is 1138 Mayport Road, City of Atlantic Beach, County of Duval, State of Florida 32233 and the name of its initial registered agent at such office is Alexandria Burwell.

**ARTICLE VI - DIRECTORS**

The Board of Directors of the Corporation shall consist of at least one (1) director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws. The number of directors constituting the initial Board of Directors is in one (1), and the


#### **ARTICLE VII - INCORPORATOR**
