Article XIII – Amendment



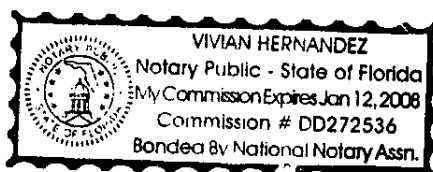
