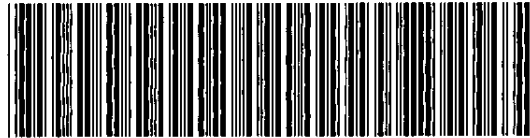

The undersigned Incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I NAME

The name of the corporation shall be:

AVRAM M. COOPERMAN, M.D., P.A.

ARTICLE II NATURE OF BUSINESS

The general nature of the business of this corporation is to be engaged in the practice of medicine. This corporation is organized and shall be operated by licensed professionals for the purposes set forth in the Florida Statutes, and any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other State, country, territory or nation.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 5,000 shares of common stock having \$1.00 par value per share.

ARTICLE IX INDEMNIFICATION


Every director, officer, employee, or agent of the corporation shall be indemnified by the corporation against all expenses and liabilities, including attorney fees, reasonably incurred or by


