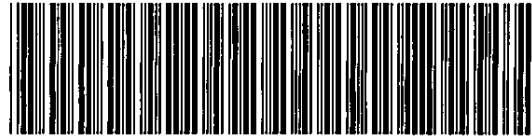

**ARTICLES OF INCORPORATION**

**OF**

**ON COURSE OPERATIONS, INC.**

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of this Corporation is: ON COURSE OPERATIONS, INC.

**ARTICLE II - NATURE OF BUSINESS**

The Corporation is to provide golf course operation services and related activities to the public and to businesses.

**ARTICLE III - CAPITAL STOCK**

The authorized capital stock of the Corporation shall be 1000 shares of common stock at a par value of \$1.00 per share. The issued stock will be 100 shares of common stock at a value of \$1.00 per share as the initial stock.

**ARTICLE IV - TERM OF EXISTENCE**

This Corporation is to exist perpetually.

**ARTICLE V - PREEMPTIVE RIGHTS**

Every Stockholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others. The By-laws explain in detail the rights of shareholders in the purchase and sale of corporation stock.

#### **ARTICLE VI - PRINCIPAL OFFICE AND MAILING ADDRESS**

The initial street address of the principal office is 1476 BARRINGTON CIRCLE, ST. AUGUSTINE, FL 32092 and the mailing address of the corporation is 1476 BARRINGTON CIRCLE, ST. AUGUSTINE, FL 32092. The Board of Directors may from time to time move the principal office and mailing address to any other address in Florida.

#### **ARTICLE VII - DIRECTORS**

This Corporation shall have ONE (1) Director initially. The number of directors may be increased or diminished from time to time, by Bylaws adopted by the Stockholders.


## **ARTICLE XII - AMENDMENT**


