**ARTICLE I - NAME**

The name of the Corporation is Carcase Management, Inc., (hereinafter, "Corporation").

**ARTICLE VII – CORPORATE CAPITALIZATION**

**ARTICLE IX - SHAREHOLDERS' RESTRICTIVE AGREEMENT**

All of the shares of sock of this corporation may be subject to a Shareholder's Restrictive Agreement containing numerous restrictions on the rights of shareholders of the Corporation and transferability of the shares of stock of the Corporation.

**ARTICLE X - TERM OF EXISTENCE**

This Corporation shall have perpetual existence.

**ARTICLE XI - VOTING RIGHTS**

Shareholders of the Corporation will have such voting rights as are provided in the By Laws of the Corporation.

**ARTICLE XII - LIABILITIES FOR DEBTS**

Neither the sharcholders nor the members of the Board of Directors or officers of the Corporation shall be liable for the debts of the Corporation.
