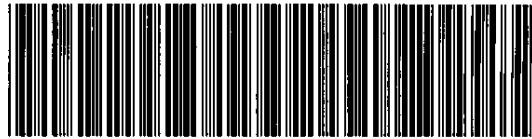

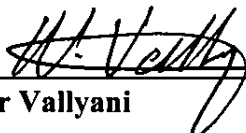
## ARTICLE VIII - PREEMPTIVE RIGHTS
