ARTICLE I. NAME

The name of this corporation shall be **CRIPPEN OUTFITTING, INC.**

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Division of Corporations, Florida Department of State. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE

This corporation is being organized for the purpose of owning and operating an outfitting establishment largely dealing in retail sales of fishing tackle and other sporting equipment of all types. This corporation is further authorized to engage in the transaction of any and all other business activities permitted under the laws of Florida and of the United States Of America.

ARTICLE IV. CAPITAL STOCK

This corporation shall have the authority to issue 1,000 shares of One Dollar (\$1.00) par value common capital stock.

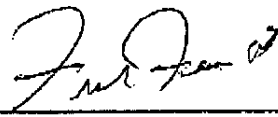
