OF

The undersigned signator of these Articles of Incorporation, competent to contract, does hereby make declaration to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be RUEL INVESTMENTS, INC.

ARTICLE II. OBJECTIVES AND POWERS

This corporation is formed for the purpose of conducting a business that will be primarily
