ARTICLES OF INCORPORATION OF EMMA'S ROSE COMPANY

ARTICLE I - NAME

The name of the corporation shall be Emma's Rose Company (hereinafter, the "Corporation" or the "Company").

ARTICLE II -- PURPOSE

The purpose for which the Corporation is organized is to engage in the conduct of any and all lawful activity or business.

ARTICLE III - PRINCIPAL OFFICE AND MAILING ADDRESS

The initial principal office and mailing address of the Company shall be 764 – 71st Terrace South, St. Petersburg, Florida 33705.

ARTICLE IV - CAPITAL STOCK

The authorized capital stock of the Corporation shall be 10,000 shares, par value \$.01 per share, designated as common stock.
