ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is ARCOS COMMERCIAL CLEANING, INC. and its principal place of business shall be located at 7206 STONE ROAD, PORT RICHEY, FLORIDA 34668.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.
