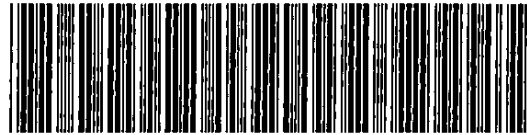

ARTICLE I – NAME

The name of this corporation is MECCA SERVICES GROUP, INC.
