#### ARTICLES OF INCORPORATION

#### **ANCIENT SECRETS 22, INC.**

The undersigned hereby state for the purpose of forming a corporation under the laws of the State of Florida, providing for the formation, rights, privileges, immunities, and liabilities of corporation for profit:

#### **ARTICLE 1.**

The name of the corporation shall be:

#### ANCIENT SECRETS 22, INC.

#### ARTICLE II.

The general nature of the business and objects and purposes proposed to be transacted and carried on, are to do any and all things herein mentioned, as fully and to the same extent as natural persons might or could do, to wit:

- A. To produce oils, oil components, etc. for use in aromatic therapy for sale to the retail and general public.
- B. To buy, sell, rent and lease automobiles, vans, trailers, boats, trucks or other vehicles for the use of the corporation.
- C. To buy, sell, rent, lease or operate any other items pertaining to oils to the general public.
- D. It is the intention that each of the objects, purposes and powers specified in each of the paragraphs of this Articles of Incorporation shall, except where otherwise so specified, be nowise limited or restricted by reference to or interference from the terms of any other paragraph or of any other Article in these Articles of Incorporation, but that the objectives, purposes and powers specified in the article, and in each of the article or paragraphs of these articles, shall be regarded as independent objects, purposes and powers of this corporation, nor shall the expression of one thing be deemed to exclude

another, although it be of a like nature. The enumeration of objectives or purposes herein shall not be deemed to exclude or in any way limit by inference, any powers, objectives or purposes which this corporation is empowered to exercise, whether expressly by force of these laws of the State of Florida, now or hereafter in effect or implied by any reasonable constrictions of said law.

#### **ARTICLE III.**

#### COMMON STOCK

The maximum number of shares of the corporation shall be One Thousand (1,000) shares, each having a par value of One Dollar (\$1.00) per share; and to be fully paid in and non-assessable; all of which will be common stock; and Five Hundred (500) shares shall be issued and sold for such consideration as may be fixed by the Board of Directors hereof. Said shares of stock shall be issued, sold or transferred only in accordance with the By-Laws of the Corporation as the Corporation may from time to time make, and all of said shares of stock subscribed to shall be paid for either in cash, property, labor or services, it being recognized that property, labor or services rendered may be purchased or paid for with the common stock of the Corporation as a just valuation.

#### ARTICLE IV.

#### AMOUNT OF CAPITAL TO BEGIN BUSINESS

The amount of capital with which this Corporation shall begin business shall be not less than One Thousand (\$1,000.00) Dollars, including cash and equipment.

#### ARTICLE V.

This Corporation shall have a perpetual existence unless dissolved according to the law.

#### ARTICLE VI.

The principal place of business of the Corporation shall be 5809 Hollywood Boulevard, City of Hollywood, County of Broward, State of Florida. Said Corporation shall have full power and authority to transact business and to establish offices and agencies

in other places both within and without the State of Florida and in any foreign countries.

#### **ARTICLE VII.**

The business of the Corporation shall be conducted by a Board of Directors of not less than one nor more than three, to be increased at the discretion of the Board of Directors.
