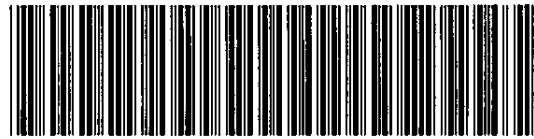

GOING -GREEN, COM CORP.

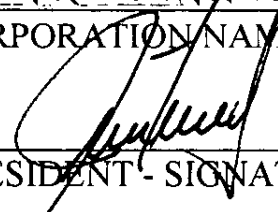
AMENDMENT ARTICLE
