**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, desiring to form a corporation under and pursuant to the Florida Business Corporation Act, Chapter 607.0203, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is GREENHAWT INVESTMENTS, INC. (the "Company").


ARTICLE VI. BOARD OF DIRECTORS
