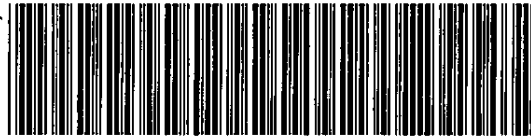

#### **ARTICLE VII. PRE-EMPTIVE RIGHTS**

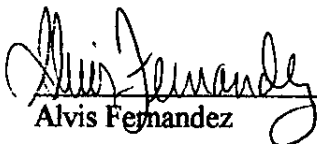

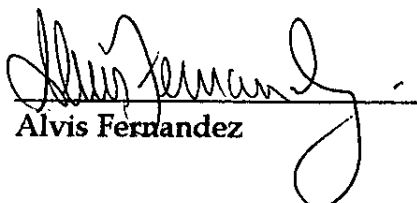

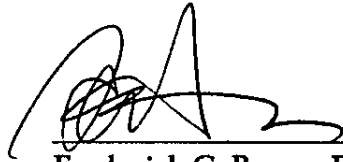
