THE UNDERSIGNED subscriber to these Articles of Incorporation, a natural or c - person, competent to contract, hereby forms a Corporation under the laws of the State on the of Florida.

### ARTICLE I - NAME

# The name of this corporation is BEAUTIFUL SMILES MANAGEMENT, INC.

#### **ARTICLE II - NATURE OF BUSINESS**

To the same extent as natural persons might or could do, the Corporation shall have the power:
