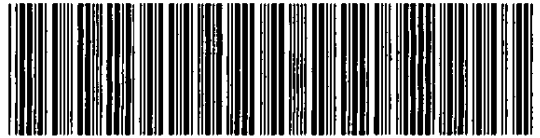

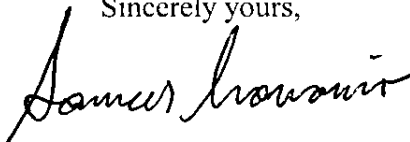

1. The Articles of Incorporation for **TIRE PALACE INC** were filed with the Department of State on June 12, 2007.

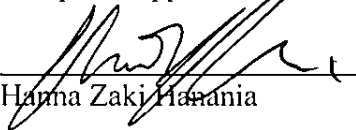

5. The corporation's Registered Agent name should be amended to Hanna Zaki Hanania whose address is 8129 103rd Street, Jacksonville FL 32210.

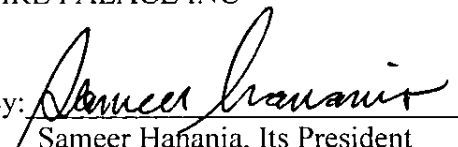
