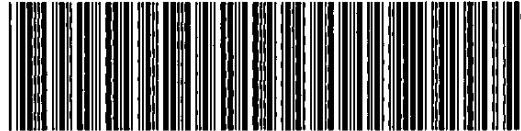



In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is **ART CREATES INC.**

ARTICLE II

The existence of the corporation shall begin as of the date of filing of these articles of incorporation with the Florida Department of State.

ARTICLE III

The street address of the principal office of the Corporation is 104 Burningtree Lane, Boca Raton, Florida 33431.

ARTICLE IV

The purpose for which this corporation is organized is to provide art consulting services; to sell art related products; to act as an agent for artists; conduct educational seminars relating to art; and such other businesses for profit which the Corporation deems advisable and suitable for the Corporation to engage in.

ARTICLE V

The maximum number of shares this Corporation is authorized to issue is 100, all of which shall be Common Shares having a par value of .01 per share. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE VI

The initial street address of the Corporation's registered office is 1882 Capital Circle N.E. Suite 206, Tallahassee, Florida 32308.. The initial registered agent for the Corporation at that address is **H. RICHARD BISBEE, ATTORNEY AT LAW.**

ARTICLE VII

ARTICLE X


The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
