

ARTICLE XII AMENDMENTS

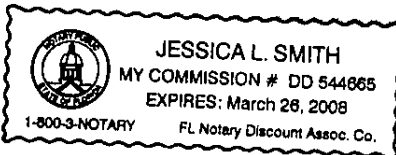




