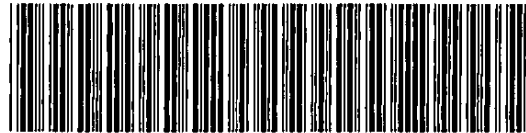

FOR

BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under Florida law.

- I. NAME:** The name of the corporation shall be **TRUE VALUE APPRAISAL OF NORTH WEST FLORIDA, INC.**
- II. TERM:** This corporation shall exist perpetually.
- III. PURPOSE:** The purpose of this corporation is to transact any and all business for which corporations may be incorporated under Florida law.
- IV. CAPITAL STOCK:** This corporation is authorized to issue 10,000 shares of common stock with a par value of \$1.00 per share. The stockholders may dispose of the authorized and unissued stock from time to time. No stockholder has a preemptive right to purchase unissued, or treasury stock, or securities convertible into or carry a right to subscribe to or acquire stock.
- V. REGISTERED AGENT:** The initial registered agent for this corporation is James M. Davis. The registered agent's office is located at 12620 Lillian Hwy. Pensacola, Fl 32506.

VI. DIRECTORS: This corporation shall have no directors. The business of the corporation shall be managed by the stockholders.
