### **Article VII – Registered Agent**



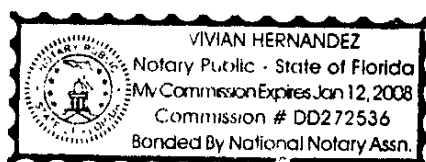
